

SECTION 1: INTRODUCTION

1.1 EAST BRIDGEWATER HOUSING AUTHORITY

The **East Bridgewater** Housing Authority (hereinafter, "Authority") is a public entity that provides subsidized housing and housing assistance to low-income families, within the **Town of East Bridgewater**, Massachusetts. The Authority is headed by an Executive Director and is governed by a Board of Commissioners and is subject to the requirements of Title 24 of the Code of Federal Regulations, Mass. General Law, and the Authority's procurement policy.

Currently, the Authority owns and/or manages: **129 Elderly/Disabled Housing units; 8 Family Housing units; and 1 building (8 units) running under State Chapter 689 Housing**, throughout the **Town of East Bridgewater**.

The Authority is requesting Sealed Bids for Supplies and Services procured under M.G.L. c 30B from qualified Vendors to provide, deliver and install **KITCHEN APPLIANCES** as specified in the enclosed documents. The successful bidder will be required to sign a contract with the Authority for the supplies and services as specified herein this IFB.

The contract price is a fixed price equal to the pricing established on the attached Form for Bid.
